Abbottstown Borough Council Meeting June 18, 2015

Meeting was called to order in the Council Room at 7:02 p.m. by Council President April Trivitt.

PUBLIC COMMENT:

 Laura Carson commented that Council should pursue grants that are available from the state, through the county for the new Borough Office. She also feels that a brick building is not necessary; that a Morton building is sufficient.

NEW OFFICE MUNICIPAL BUILDING:

• Report from the Construction Committee Mark reviewed the bid results. Chad indicated that the electric could be re-bid separately, but that would set the beginning of the construction back at least one month because the electric contract is needed for demolition and the beginning of construction. Chad stated that if the council re-bid the entire job in the fall with a start date of early 2016, giving the contractor 9 months to complete, there is a chance the bids would come in lower. Walter feels the cost (\$500,000) is too high for the borough for a project of this size. He sees Mark's and Hugh's points, but feels there must be other less expensive alternatives. The current rent even if it doubles, could still be half of what a loan payment would be for the construction. Mark commented that if the building were to have been built the last time plans were developed, twenty years ago, it would have been paid for by now. Dale feels it's premature to vote on the award of the contracts before Council knows where the money is coming from and how the borough is going to sustain the 20 or 25 year repayment plan.

 - Mowing Contract April has noticed that the contractor is not weeding around the buildings. Walter will be in contact with the contractor to resolve the issue.

 - Craig asked who Don Myers (maintenance) take direction from. Don usually let's April know if he sees problems to be corrected. It was suggested that anyone else who wants work done by Don should run it through the Borough Office.
- Sidewalk and Street
 - Craig asked if Don has a pesticide license to spray vegetation on the roads.
 Chad indicated that street/road sealing is on the Five Year Street Repair Plan.
 - Dale presented the June 11th meeting minutes. Chad reviewed the proposed 2015 street repairs on Sutton Road and the culvert work at the intersection of South Country Club Road and East Fleet Street. Originally both projects were estimated at \$150,000, but after being designed it is estimated at \$200,000 (Sutton Rd @ \$180,000). The committee recommends separating the two jobs due to the increase. The culvert work can be done in early 2016.
