<u>J.A. Myers Subdivision on Sutton Road</u>: Comment letter has been written up but nothing else is ready for Council action at this time. Mr. Reichert is opposed to a single access cul-de-sac for emergency purposes. Updates will be forwarded as the project progresses.

Update on Center Square accidents: repair process ongoing.

Peterson Family Trust subdivision: Revised plan to be submitted but will not affect borough. Resident wants approval so they can proceed with sale of property. Engineer recommends conditional approval pending comments from other municipalities involved. Solicitor also represents resident and cannot comment on these proceedings. President Posey suggests a motion be made for conditional approval. *Motion made by Frank Anderson to grant conditional approval to Peterson Family Trust subdivision plan as discussed; Seconded by Dale Reichert; Motion carried, 5 Ayes*. Mr. Shultis interjects concerning the amendments to the Sunshine Law concerning actions not listed on the agenda, advising Council of their options. President Posey suggests adding the issue to the next agenda on October 7th. *Motion made by Frank Anderson to rescind previous conditional approval; Seconded by Dale Reichert; Motion carried, 5 Ayes*.

ADMINISTRATIVE REPORTS: Mr. Bolton is attending the PSAB Board meeting and Leadership Conference in Erie, PA. He leaves the agenda question, "Does Council wish to process RFPs for any services for 2022?" President Posey states that he does not feel the process is needed this year. VP Reichert does not want to create more work for Mr. Bolton.
