2017 Stormwater Improvements – Committee recommends abandoning Clinton Alley after completing the following improvements: remove the pavement on Clinton Alley; fill the low area where ponding occurs with soil; reestablish the private stone drive off Water street to the existing residence/garage; grade along the back of Ivy Hall to provide positive drainage to a pipe that will be install along Water Street down to the existing inlet at the intersection of Abbott St.

Chad will speak to the property owners at 337 West King Street and 381 West King Street to explain the proposal and get their reactions.

Motion made by Daniel Watkins that Chad will move forward with the Clinton Alley talking to both property owners. If both property owners agree, he moves forward with the project, reports back to council with a ratification for next month; 2nd Dale Reichert; Motion carried, 5 Ayes

Chad asked about advertising the project. Dennis said if both property owners agree to the borough abandoning the alley, then Chad could go ahead and get things going. The only thing that would come into play is if one or both parties disagree. If Chad gets a verbal agreement from the property owners, then he will draw up a design, send it to Guy and have Guy write up an agreement for property owners to sign prior to construction.
