## A RESOLUTION OF THE BOROUGH OF ABBOTTSTOWN PROVIDING FOR SUPPLEMENTAL APPROPRIATIONS FOR THE 2022 BUDGET

Resolution 2022-11

## WHEREAS.

On March 11, 2021, the American Rescue Plan Act of 2021 became law, providing to the Borough of Abbottstown (the "Borough") a non-competitive federal formula grant from the U.S. Treasury Department (the "Treasury") totaling \$53,066.67, identified as Coronavirus State and Local Fiscal Recovery Funds ("CSLFRF"); and

On May 17, 2021, the Treasury published an Interim Final Rule for the use of the CSLFRF; and

On November 9, 2021, the Borough Council approved a budget for the calendar year 2022; and

On January 27, 2022, the Treasury issued a Final Rule, which modified the regulations contained in the Interim Final Rule; and

The Final Rule offers a standard allowance for revenue loss of up to \$10 million, allowing recipients to elect a standard amount of revenue loss or complete a full revenue loss calculation; and

Recipients of CSLFRF that select the standard allowance may use that amount — in many cases, their full award — for government services, with streamlined reporting requirements; and

Section 1312 of the Borough Code authorizes the Borough Council to, by motion, modify the budget after its final adoption and to make new or supplementary appropriations and transfers during the fiscal year, 8 Pa. C.S. § 1312; and

The Borough Council wishes to provide for supplemental appropriations of the CSLFRF from the 2022 Borough budget in accordance with the Final Rule as published by the Treasury.

NOW, THEREFORE, be it resolved by the Council of the Borough of Abbottstown as follows:

- SECTION 1. The above recitals are incorporated herein by reference and made a part hereof.
- The Borough Council hereby elects the revenue replacement standard allowance in accordance with the SECTION 2. Final Rule, to include the Borough's 2<sup>nd</sup> tranche supplement of \$53,066.67 issued on September 9, 2022.
- Proper Borough officials are hereby authorized to file with the Treasury any report or document necessary; SECTION 3. and further, to make appropriations as government services from revenue replacement as authorized by the Final Rule, with specific categories of eligibility as detailed in the Final Rule for the expenditure of CSLFRF.
- Proper Borough officials are authorized to execute any documents necessary for proper compliance with SECTION 4. the Final Rule for the expenditure of CSLFRF.
